### Item 2: Acquisition or Disposition of Assets

### Introduction

MacroAsia Corporation ("MAC") signed a Sale and Purchase Agreement ("SPA") with SATS, Ltd. ("SATS") on 22 July 2015. Pursuant to the SPA, MAC agreed to sell 162,500 shares representing 13% of the total issued and outstanding capital stock of its subsidiary, MacroAsia Catering Services, Inc. ("MACS") to SATS. MACS is the dominant airline catering company in the Philippines.

MAC currently owns eighty percent (80%) of the total issued and outstanding capital stock of MACS. Upon completion of the transaction, MAC's shareholdings in MACS will be reduced to sixty-seven percent (67%). SATS' shareholdings in MACS, on the other hand, will increase from twenty percent (20%) to thirty-three percent (33%) of the total issued and outstanding capital stock of MACS.

### **Completion of Transaction**

As the Parties have obtained the required regulatory approvals as of 22 January 2016, the transaction was deemed completed as of said date.

Following completion of the transaction, the updated shareholdings in MACS is set forth hereunder:
