(CPCS), a joint venture of MacroAsia Corporation with Cathay Pacific Catering Services of Hong Kong, and MGO Pacific Resources Corporation, in its regular board meeting today, 23 September 2025, has declared Seventy Million Pesos (Php70,000,000) cash dividends payable on or before 31 October 2025 to MacroAsia Corporation (40%) and Cathay Pacific Catering Services of Hong Kong (40%) and MGO Pacific Resources Corporation (20%). MacroAsia's share in this dividend declaration is Twenty-Eight Million Pesos (Php28,000,000).

Cebu Pacific Catering Services, Inc. (CPCS), formerly MATS Catering, is the first inflight catering venture of MacroAsia Corporation (MAC). CPCS is the only full-service airline catering company that operates at the Mactan-Cebu International Airport (MCIA).
