MacroAsia Corporation ("the Corporation") has been informed that a member of the board of directors has died. It is with deep sympathy that we report the demise of Treasurer/Director Mr. Lucio K. Tan, Jr. He passed away last 11 November 2019 at the age of 53.

Mr. Tan has served as Director of the Corporation since August 1997 and Treasurer since July 2019.

Below is the official statement of the Tan Family with regards to the matter.

"The Tan family announces with deep sorrow the passing of Lucio "Bong" K. Tan, Jr. this morning, November 11, 2019. He was 53.

Prior to his untimely passing, Bong, as he is fondly called by family and friends, held board positions in the following listed companies: LT Group, Inc., PAL Holdings, Inc., Philippine National Bank, MacroAsia Corporation and Victorias Milling Company, Inc. He was also President/COO of Tanduay Distillers, Inc. and held other board and executive positions in various member firms of the Lucio Tan Group. He is survived by his wife Julie, sons Lucio Tan III and Kyle Tan, parents Lucio and Carmen, siblings, nephews and nieces.

The Tan family is requesting for prayers for the eternal repose of his soul. Wake details to be announced."
