Item 9. Other Events

Please be advised that during the Regular Board Meeting of MacroAsia Corporation (the "Corporation") held on 22 March 2018, the Board approved the following matters:

a) **Audited Financial Statements**

The Board approved the Consolidated Audited Financial Statements of the Corporation and its subsidiaries for the year ending 31 December 2017.

b) Annual Stockholders' Meeting

The Board approved the holding of the Annual Stockholders' Meeting ("ASM") on 20 July 2018 (3rd Friday of July), in accordance with Article II, Section 2.01 of the Amended By-Laws of the Corporation.

Stockholders of record as of 20 June 2018 are entitled to notice of, and to vote at the ASM.

c) Spin-off of Water Subsidiaries

The Board approved the spin-off of the water subsidiaries from MacroAsia Properties Development Corporation to a holding company under the control of the Corporation.

The Board likewise approved the following matters subject to the approval of the stockholders of the Corporation at the ASM:

a) Declaration of Stock Dividends

The Board of Directors approved the declaration of thirty percent (30%) stock dividends equivalent to Three Hundred Sixty Eight Million One Hundred Forty Six Thousand Three Hundred Twenty (368,146,320) shares (the "Shares") from the unrestricted retained earnings of the Corporation, based on the Audited Financial Statements of the Corporation for the year ending 31 December 2017.

The Shares will be taken from the unissued portion of the authorized capital stock of the Corporation.

The record date and payment date shall be set after stockholders' approval and approval by the relevant regulatory agencies have been obtained by the Corporation.

b) <u>Extension of Corporate Term</u>

The Board approved the amendment of the Fourth Article of the Articles of Incorporation to extend the corporate term of the Corporation for another fifty (50) years.
